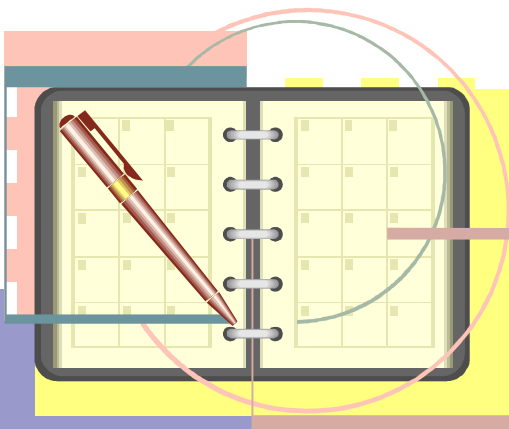

## HURRICANE UPDATE from Mahendra Amarasuriya, LCIF

This summer there were a great number of hurricanes throughout the Caribbean and U.S. Gulf Coast. The destruction was significant, killing thousands and destroying properties across several countries and states from wind damage to flooding. Similar to past disasters, Lions and LCIF quickly responded to provide immediate relief items and help families to get back on their feet.

Hurricane Gustav caused \$20 billion in damage and caused great flooding damage in Mississippi, Louisiana and Texas, areas previously hard hit by Hurricane Katrina in 2005. LCIF issued five Emergency grants to Lions districts in Mississippi and Louisiana, totaling \$50,000 in relief funds. Grants totaling \$15,000 were also awarded to Lions in the Dominican Republic and Mexico.

Hurricane Ike, the ninth hurricane of the summer, also hit the Gulf Coast of the U.S., making landfall in Texas and causing destruction along hundreds of miles of coastline. LCIF has issued five Emergency grants to districts in Texas and Louisiana, totaling \$50,000 for immediate needs.

LCIF has responded to a number of recent natural disasters around the world. Since July 1, LCIF has issued \$464,000 in Emergency grants. LCIF continues to be in touch with Lions in the affected areas to assess the situation and respond as needed.

Emergency grants and Major Catastrophe grants are funded through LCIF's general humanitarian fund. ### Lion Hisao Inouye - Lions Life Member and Nikkei Lions Club Charter Member .

Lion Hisao was born March 10, 1908 in Kobe, Japan and in 1955 he became a naturalized U.S. Citizen. He was very active in community affairs helping to organize and serving as an officer in many organizations. In November 1988, the Government of Japan conferred on him The Order of The Sacred Treasure, Gold Rays with Rosette, in recognition of his years of outstanding work in promoting relations between Japan and the United States. In 1961, Lion Hisao helped organize the Nikkei Lions club and served as President in 1962. He was Cub Lion of the Year in 1968 and in 1965 served as the District Chairman of the Lions Youth and Community Activities

## Fair Oaks Lions Club gets off the ground

Two of the Fair Oaks Lions Club's primary backers have very different levels of experience with the historic service organization.

Laura Castillo, 24, has never belonged to a Lions Club before. Still, she is helping the recently chartered branch of the international group to serve the unincorporated North Fair Oaks area near Redwood City. Bill Gibbons, 76, has been a member of the Sunrise Lions Club in Redwood City since 1970 and is in his fourth term as president. His job as a "guiding lion" is to make sure Castillo, the club president, succeeds in getting her club off the ground.

Parque de la Amistad, or Friendship Park, at Dumbarton and Curtis avenues, is one of the Fair Oaks club's first projects. The club has volunteered to clean the park regularly to ease the burden for the cash-strapped San Mateo County Parks Department. The group was recognized last month by the Redwood City Council for its efforts.

As it adds members and chooses projects, the club is shattering stereotypes. While Gibbons said that the clubs have often consisted of mostly senior-age men, 18 of the 22 members in the Fair Oaks club are women, mostly in their 30s and 40s.

"I saw that there's so many clubs through this whole area," Castillo said. "I feel like our community needs one most, and there was nothing being done, so I felt like no matter what it takes, or how hard I have to work, or how long it takes me to get people interested in it, I have to do it."

## Fair Oaks Lions Club gets off the ground

County parks director Dave Holland said that the club's help with maintenance at the park should keep it from becoming a gathering place for unsavory characters. "When you get the neighborhood involved, that kind of prevents that," he said. "They kind of take over keeping an eye on the park."

Castillo, who started knocking on doors about a year ago, said the club has organized a few fundraising events so far, including a food booth at the recent North Fair Oaks festival, and it is planning a rummage sale next month. In line with a longtime mission of the international Lions Club, the Fair Oaks club is trying to raise money to help the visually impaired.

"In our area, there are a lot of kids who can't afford eyeglasses," said Paula Martinez, 46, the club's vice president. "They don't have insurance because they are not legal residents."

Among the challenges of starting the club are the members themselves. Martinez said most members work and many have school-age children, which makes it difficult to plan meetings.

In Gibbons' club, "The average age now is probably 60 or better," he said. Another hurdle is recruiting members, which Gibbons said has been hard for his club and others in the area. He has encouraged some reluctant members of Castillo's club to take anyone they can. "If they don't like somebody, they want to kick them out of the club," he said. "I said, 'Wait a minute — it takes an awful lot of effort to get members!' You've got to run a club like a business, and they don't know that yet."

Castillo said she hopes to work on future projects to help local schools. She is attending Foothill College and wants to be a teacher.

"I want principals, I want nurses, I want schoolteachers to be able to call me and say, 'We need help,' and me find a way to get their resources to them," she said. "The need, to me, is obvious if you spend a day at one of these communities."

### NEW TAX FILING REQUIREMENT— AFFECTS LIONS CLUBS

If you are a small tax-exempt organization that normally has annual gross receipts of \$25,000 or less and does not have to file Form 990 or 990-EZ, you must file the e-Postcard (990-N) If you do not, you risk losing your tax exempt status.

If your fiscal year is July 1—June 30, you need to file no later than November 15, 2008. Club Presidents should have received a letter explaining the requirement. If you have not received the letter, or if you have questions, please contact Lion Mike Simonini.
